Insurer confirms herewith that the insurance policy above was contracted between the insurer and policyholder; as at the day of issue, this insurance policy covers – in the scope defined in the policy incl. insurance terms and conditions that form an integral part – carrier's liability to compensate damage inflicted to tangible movable items which the insured took over in order to transfer them as load by a road vehicle listed in the insurance policy, unless the obligation to compensate such damage arises from the Czech legislation, incl. Convention on the Contract for the International Carriage of Goods by Road (CMR Convention)

Commencement of the force of insurance in the scope below: 15. 1. 2024
Insurance end: 14. 1. 2027
Compensation limit: 2 000 000 CZK
Covered territory: **Europe** incl. the Czech Republic **except for countries of former Soviet Union (Lithuania, Latvia and Estonia are not excluded)**, if not agreed differently in the Insurance Policy.
Insured: identical with policyholder

In case of discrepancies, the Czech version shall prevail.

The Insurance covers also the liability insurance during cabotage transports.
The liability insurance during cabotage transport is contracted in compliance with the Regulation (EC) No. 1072/2009 of the European Parliament and of the Council on Common Rules for Access to the International Road Haulage Market and with the applicable legislation of the member state for which the liability insurance during cabotage transports is contracted herewith.

The insurance covers the obligation to compensate for the damage caused to the freight during cabotage transports carried out within the territory of:

The insurance covers the obligation to compensate for the damage caused during cabotage transports carried out by motor vehicles:

For the liability insurance during cabotage transports within the territory of the Federal Republic of Germany (BRD) the maximum annual indemnity limit for all claims incurred during one insurance year amounting in total to EUR 1.200.000 has been contracted; the indemnity limit for one claim amounting to EUR 600.000 has been contracted within the above limit.

The liability insurance during cabotage transports also covers the cabotage carried out within the territory of the United Kingdom of Great Britain and Northern Ireland (hereinafter referred to as "Great Briatain"), provided that the Insured legitimately carries out the cabotage within the territory of Great Britain, in compliance with conditions arising from legal regulations incl. relevant provisions of the Trade and Cooperation Agreement between the European Union and the European Atomic Energy Community, of the one part, and the United Kingdom of Great Britain and Northern Ireland, of the other part.
